# Section 4. First aid measures

Eye contact	<ul> <li>Immediately flush eyes with plenty of water for at least 20 minutes, occasionally lifting the upper and lower eyelids. Get medical attention if symptoms occur.</li> </ul>

### Section 7. Handling and storage


